# About the Performer

Pianist **Hans Boepple** has been presented as guest soloist with distinguished American orchestras since his debut with the Los Angeles Philharmonic at age 10. Concerto appearances include the Hollywood



Bowl, Denver Symphony, Minnesota Orchestra, Santa Rosa Symphony, Long Beach Symphony, Metropolitan Opera House Orchestra, San Diego Symphony, and Santa Cruz Symphony.

Active as both featured soloist with orchestra and in solo recitals for over thirty-five years, Hans Boepple has been honored by being placed on the Steinway International Artist Roster. He has been

featured artist on college, university and civic concert series across the United States, and performances have been broadcast by the National Broadcasting Company (NBC), National Public Radio, Sudwestfunk, and Voice Of America.

Mr. Boepple has recorded the complete Beethoven Bagatelles for Orion Master Recordings. His three recent recordings by the Kjos Music Company are part of their Master Composer Collection of Piano Literature.

Hans Boepple holds a Master's degree in Piano Performance from Indiana University, as well as the prestigious Performer's Certificate. A former member of the piano faculty at Indiana University School of Music, Mr. Boepple is a tenured full professor at Santa Clara University. He joined the faculty in 1978 and has served as chair since 1995.

In demand as an adjudicator, lecturer, and master teacher, Mr. Boepple continues to balance demanding performance activities with those of a dedicated and successful teacher. His students have earned more than 100 state, national, and international awards.
